

Ambient Water Signs Memorandum of Understanding with Penida Capital for Exclusive Manufacturing and Sale of AW2500 in Indonesia

Both companies to publically sign MOU at ASEAN Mayors and Makassar Investment Forum; Ambient Water CEO Keith White also to speak as part of “SMART CITY in Makassar, Making it Work” panel

SPOKANE, WA – September 8, 2015 – Ambient Water (OTCQB: AWGI), a leading provider of atmospheric water generation systems for extracting water from humidity in the air, today through its subsidiary, announced the signing of a Memorandum of Understanding (MOU) with Penida Capital Advisors Ltd., an Indonesian corporation, for exclusive rights to manufacture and sell the AW2500 within the 10-member economies of ASEAN (Association of Southeast Asian Nations). The MOU is non-binding and contemplates the preparation and execution of definitive agreements.

Members of ASEAN’s 620-million population region include Indonesia, Philippines, Vietnam, Thailand, Malaysia, Singapore, Brunei, Cambodia, Laos, and Myanmar. Both companies will sign the MOU publically on Tuesday, September 8, 2015 at the ASEAN Mayors and Makassar Investment Forum taking place in Indonesia.

The MOU will allow Penida Capital, through a Special Purpose Company, to establish an exclusive manufacturing license in the ASEAN region for the AW2500, Ambient Water’s residential model of its atmospheric water generation technology, which can produce up to five gallons of drinkable water per day from the humidity which exists in the air. Additionally, Penida Capital, through a special purpose company, will sell Ambient Water’s commercial and industrial units such as the flagship AW400. The commercial and industrial units can produce anywhere from hundreds to thousands of gallons of water per day, making them an ideal solution to bulk water needs. The MOU contemplates that Ambient will own a 30% equity stake in the Special Purpose Company.

“Indonesia has had some well documented issues with water – notably an inadequate supply and challenges with delivery and cleanliness. These issues have slowed economic growth in under-serviced regions which require a clean and sustainable water solution,” said Keith White, Founder and CEO of Ambient Water. “Through this agreement with Penida Capital, we will strive to bring a safe water source to homes, businesses, and other areas with bulk water needs throughout the entire ASEAN region, so that everyone will be able to drink without fear of illness. We’re thrilled to be working with Penida Capital and to bring our technology in to this strategically important region.”

“We are excited to enter into this MOU with Ambient Water for delivering a sustainable source of clean, drinkable water to Indonesia and ASEAN,” said Dewi Sri Umi, Managing Director, Penida Capital. “The ever-increasing demands of the region requires a solution that can provide a safe and continuous water source, and we believe Ambient Water’s technology does just that.”

Ambient Water CEO Keith White will also be part of a panel at the ASEAN Mayors and Makassar Investment Forum called "SMART CITY in Makassar, Making it Work!" on Tuesday, September 8 from 13:30-15:00 Central Indonesian Time. White will join other business leaders in a discussion on how innovations can improve Makassar as a city and for its residents.
